Whereas the first trustees mentioned below hereto have given their consent to be the trustees for administering the affairs of the Trust in accordance with the terms and conditions hereinafter provided.

Whereas the settlor of the Trust had declared and constituted a Public Charitable Trust for the benefit of the society at large, without distinction of caste, religion, race, gender or place of birth.

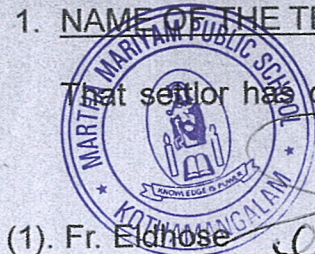
Whereas the Settlor has set apart a sum of Rs.1000(Rupees One thousand only) in favour of the Trust forms as a corpus Fund for the said Trust and Whereas the said sum of Rs.1000 (Rupees One thousand only) has been transferred, paid and handed over to the Trustees named below on 15th day of August Two thousand Seven.

1. NAME OF THE TRUST

2. INTER PARTITIONS

In this deed, unless the context otherwise requires the following word or words shall have the meaning or meanings as stated below.

- a). Church shall mean Martha Mariyam Cathedral Valiyapally, Kothamangalam.
- b). "Managing Committee" shall mean the managing committee of Martha Mariyam Cathedral Valiyapally duly elected as per the Udampady of Martha Mariyam Cathedral Valiyapally.
- c). Chairman shall mean the Vicar of the Martha Mariyam Cathedral Valiyapally, Kothamangalam from time to time.
- d). "Trustees shall mean the Trustees of the Martha Mariyam Cathedral Valiyapally and Charitable Trust, Kothamangalam nominated by the Managing Committee of Martha Mariyam Cathedral Valiyapally.
- e). 'Vicar' shall mean the Vicar of the Martha Mariyam Cathedral Valiyapally, Kothamangalam then and there.
- f). 'Trust purposes' shall mean the objectives set out under clause 6 of this deed.
- g). Trust fund shall mean the money, securities and other assets whether movable or immovable from time to time vested in the trustees and whether obtained by way of gift, purchase, loan or in any manner for the trust purposes and any accruals thereto howsoever arising.
- h). Words imputing the singular shall include the plural and vice-versa and the words is imputing the masculin gender shall include the feminine and vice-versa.

3. REGISTERED OFFICE



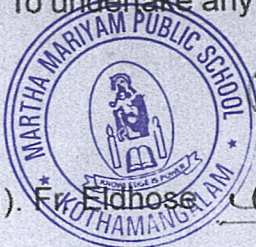

5. TRUSTEES TO HOLD THE HAND BE TRUST

The Trust stand possessed of the said sum of Rs 1000 (Rupees One Thousand only) and any other moneys and other assets which may hereinafter be received by them for the purpose of the trust included in the expression "The Trust Fund and to apply the same for the furtherance of the objective of the Trust in perpetuity and in accordance with their deed and with and subject to the powers and provisions hereinafter contained.

6. THE OBJECTIVES OF THE TRUST

- a). To establish develop and manage schools, colleges training centres Universities. Polytechnics and other Educational Institutions, (Hospitals) for imparting instructions and training in any discipline such as arts, Science Craft, Teaching, Medicine, Engineering etc including vocational training for the benefit of land open to all persons irrespective of caste, race or creed with all necessary buildings libraries, play grounds, hostels, boarding houses, residential quarters with all fittings, machinery, apparatus appliances and convenience.
- b). To provide fees, books, equipments, freeships and scholarships to deserving candidates.
- c). To make donations to other public charitable trust institutions recognised under sec.80G of the Income Tax Act 1961.
- d). To employ and remunerate employees and agents as are deemed desirable for the attainment of the objectives of the trust.
- e). To promote and advance moral Education Charity and general welfare of the people.
- f). To receive grants, subsidies, donations and aid in any form from any other organisations to promote the objectives of the Trust.
- g). To, under the agreements, execute regular deeds and documents and to do all acts and things for carrying out the objectives of the trust and to do all other acts and things incidental to or necessary to promote such objectives.
- h). To invest moneys of the Trust in such manner as may be decided from time to time.
- i). To accept, take over, and administer any other trust, organisations or institutions having similar aims and objectives.
- j). To undertake any project or activity which in the opinion of the board of Trustees may be

k). To do any and all other lawful things as the trust may deem fit.

7 TRUSTEES

The settlor hereby appoints all elected members of the managing committee of Martha Mariyam Cathedral Valiyapally, Kothamangalam as Trustees of the Trust. The first trustee shall be (1). Fr. Eldhose (Manager), (2). A.G. George (Secretary), (3). K.O. Paulose (Board Member), (4). A.K. Chackochan (Board Member), (5). K.C. Kuriakose (Board Member), (6). Reji Mathew (Board Member), (7). Eldhose Thomas (Board Member), (8). Binu Cherian (Board Member), (9). Giji Varghese (Board Member). All the above persons have accepted the appointment and agreed to be the trustees.

8. BOARD OF TRUSTEES

The above named Trustees shall constitute the Board of Trustees and shall be trustees until new trustees are appointed by the managing committee of Martha Mariyam Cathedral Valiyapally, Kothamangalam. On the death or resignation of a Trustee, the managing committee shall appoint a person as a trustee in place of the deceased or resigned. All elected members of the managing committee of the church, shall be trustees of the trust.

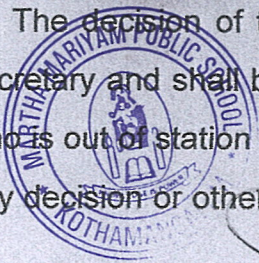
If a persons membership in the managing committee is ceased due to death, resignation or removal for whatever reason, his position as Trustee shall also be ceased automatically.

9. MEETING OF THE BOARD OF TRUSTEES:-

a). The Board of Trustees shall meet as often as required or atleast once in six months. The meeting shall be presided over by the chairman. In the event of the absence of the Chairman, the meeting will be presided over by a Trustee, chosen by the Trustees present at the meeting of the Board of Trustees.

b). The quorum for the meeting shall be 2/3rd of its members. All questions arising for decisions shall be decided by majority. At meetings the chairman shall have a casting vote, in the event of equality of votes. The voting shall be by raising of hand.

c). The decision of the Board of Trustees shall be recorded in a minutes book, by the secretary and shall be signed by all the trustees who attended the meeting. Any Trustee who is out of station or unable to attend the meeting may communicate his acceptance of any decision or otherwise in writing.

d). The decisions of the Board of Trustees shall be by a simple majority except in respect of matters for which it is otherwise provided in this Deed. Decisions can be taken by the Trustees by circulation among all the Trustees, but that a meeting shall be necessary if circulation is objected to by any Trustees.

e). Ordinarily three clear days notice shall be given for the meeting of the Trustees. However in case of emergency, a meeting may be convened in shorter notice in writing.

f). The meeting shall be called and notice for the same shall be given by the secretary. He shall be bound to call a meeting if requisitioned by atleast 8 Trustees. If the Secretary fails to call the meeting within 15 days from the date of receipt of such notice, the requisitioning trustees shall be competent to call the meeting themselves. In such a meeting the matters for discussion shall be confined only to the agenda for which the notice has been given.

10. MANAGEMENT

The Trust shall be managed by a Board of directors consisting of a Chairman, Secretary and five directors duly nominated from the board of Trustees and trustees of Marthamariyam Cathedral Valiyapally, as per clause No. 11 given below.

11. CONSTITUTION OF BOARD OF DIRECTORS

a) The board of Trustees shall nominate a Chairman, a Secretary and five directors as members of Board of Directors.

b) The Board of Directors shall be in office for a period of one year or until a new Board of Directors is appointed by the Board of Trustees.

c) The Chairman and any Director of the Board shall be removed on the recommendation of the Board of Directors by a special resolution passed in the meeting of the Board of Trustees with a two third majority of its members present, if it is found that his activities are not conducive to the interest of the Trust, or if he fails to comply with the decisions taken by the Board of Directors. The concerned Chairman or Director shall be given an opportunity of being heard by the Board of Trustees before his removal.

d). Any vacancies arising due to resignation, death, removal or if any, shall be filled by the Board of Trustees. The person so nominated shall hold office for the remaining period of the original term.

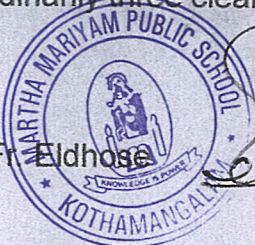
12. POWERS OF THE BOARD OF DIRECTORS

- a). To build on, pull down, rebuild, add to, alter, repair, improve, construct or reconstruct any buildings or premises for the use of the Trust or any institution under its management with the permission of the Board of Trustees.
- b). To expend the funds of the Trust as per the budgets approved by the Board of Trustees.
- c). To enter into contracts on behalf of the Trust.
- d). To prepare and adopt budgets and supplementary budgets.

13. MEETING OF THE BOARD OF DIRECTORS

- a). The Directors shall meet as often as required or atleast once in three months. The meeting shall be presided over by the Chairman. In the event of the absence of the Chairman, the meeting will be presided over by a Director, chosen by the Directors present at the meeting of the Directors.
- b). The quorum for the meeting shall be five. All questions arising for decisions shall be decided by majority. At meetings, the chairman shall have a casting vote, in the event of equality of votes. The voting shall be by raising of hand.
- c). The decisions of the meeting of the Directors shall be by a simple majority except in respect of matters for which it is otherwise provided for in this Deed. Decisions can be taken by the Directors by circulation among all the Directors, but that a meeting shall be necessary, if circulation is objected to by any director.
- d). The decisions of the meeting of the Directors shall be recorded in a Minutes Book by the Secretary and shall be signed by all the Directors who attend the meeting. Any Director who is out of station or unable to attend the meeting may communicate his acceptance of any decision or otherwise in writing.
- e). The date time and the agenda of the meeting shall be decided by the secretary in consultation with the chairman and notice for calling the meeting shall be issued stating the date, time and the agenda of the meeting by secretary. The venue shall be either at the Martha Mariyam Cathedral Valiyapally or at the office of the Trust.
- f). Ordinarily three clear days notice shall be given for the meeting of the Directors. In case

of emergency, a meeting may be convened in shorter notice in writing or orally. However in the case of meetings to consider Agenda as per Clause 12, the Secretary shall give 15 days clear notice in writing to the members.

g). The meeting shall be called and notice for the same shall be given by the Secretary. The Secretary shall be bound to call a meeting, if requisitioned by at least four Directors. If the Secretary fails to call the meeting within 15 days from the date of receipt of such notice, the requisitioning Directors shall be competent to call the meeting themselves. In such a meeting the matters for discussion shall be confined only to the agenda for which the notice has been given.

14. SEAL

The Trustees may adopt a seal as the common seal of the trust and provide for the manner in which the same may be affixed to any document deed or instrument to which the trustee is signatory.

15. POWERS AND FUNCTIONS OF CHAIRMAN

- a). Chairman shall preside over the meetings of trustees and Board of Trustees and board of directors.
- b). He shall have the authority to over all supervision of trust and its institutions.
- c). He shall jointly operate the Bank accounts with the secretary.

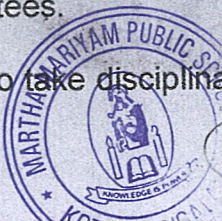
16. POWERS AND FUNCTIONS OF SECRETARY

The Secretary shall conduct the affairs and management of the Trust. All deeds and documents pertaining to the Trust Funds, shall be done by the secretary. The Trust may sue or be sued in the name of the secretary of the Trust. The secretary may delegate any of his powers and functions to any of the Directors.

17. THE SECRETARY SHALL HAVE THE POWER

a). To appoint such employees and staff as may be necessary to carry on the day today work and affairs of the trust and to fix their salaries and emoluments and service conditions with the approval of the Directors and as per the regulations approved by the Board of Trustees.

b). To take disciplinary action against the employees of the Trust, including the power to

suspend remove or dismiss them from service with the approval of Directors.

- c). Secretary shall be the manager of the educational Institutions under its management. The Secretary shall exercise such powers in suchmanner as decided upon by the Board of Directors.
- d). Incase of death, resignation or removal of the Secretary, another Trustee shall be elected for the vacant post by the Board of Trustees. The person so elected shall hold office for the remaining period of the original term.
- e). The secretary shall be responsible for calling the meeting of the Trustees and Directors. He shall maintain the minutes book where in all the decisions of the meetings of the Trustees and the directors are to be recorded. He shall also be responsible to make correspondence on behalf of the Trust and on behalf of the educational institutions under its managements in the day to day affairs, in the manner authorised by the Board of Trustees.
- f). The secretary may be removed from post by 2/3 majority decision of the Board of Trustees.
- g). The Secretary shall be responsible tokeep the regular account of the Trust,money and institutions under its managerment and shall open and operate a bank account along with the Chairman, in any of the scheduled Banks/Co.Operative Banks in the locality. He shall get the accounts audited by the internal auditors of the Trust quarterly and the annual accounts audited by the chartered Accountant.
- h). All the collection of the Trust and the institutions shall be deposited in the Bank Accounts. He shall authorise payments of trust expenditure including capital expenditure. The Board of trustees shall fix from time to time, according to the needs of the Trust/Institutions, the maximum amount of cash which can be kept with the Secretary at any give time.
- i). He shall present quarterly audited accounts of the Trust/Institutions at the Board of Directors, meeting one month of the close of each quarter and the audited annual accounts within four months of the closing of the financial year.
- j). He shall present and get the approval of the annual audited accounts of the Trust/ Institutions at the meeting of the Board of Trustees within a reasonable time at the close of the financial year.



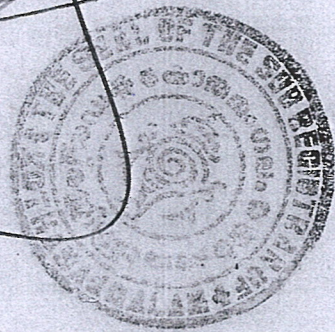

k). He shall prepare the Budget of income and expenditure including capital expenditure for each financial year, in consultation with the Chairman and the same shall be presented for approval of Board of Directors and Board of Trustees before the commencement of the financial year.

18. BANK ACCOUNT

- a). The trust can open and operate all types of bank accounts with scheduled Bank/ Co.Operative Banks.
- b). The accounts shall be jointly operated by the secretary with the Chairman.
- c). The trust can borrow money from Banks or any other financial Institution, provided this shall be on the basis of majority decisions of trustees.

19. REIMBURSEMENT

All Trustees shall be entitled to receive and be paid out of the Trust Fund, all out of pocket, including travelling and other expenses reasonably and legitimately incurred by them in connection with Trust matters.

20. FRAMING OF RULES AND REGULATIONS

The trustees from time to time, shall frame such rules and regulations for the management and administration of the Trust as they deem fit and proper and after or vary the same from time to time to make new rules and regulations, provided such rules and regulations shall not be inconsistent with any of the provisions of this Deed.

21. FINANCIAL YEAR

The Financial year shall comprise 12 months from 1st April of an year to 31st March of the following year.


